**THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.**

**WARNING: YOU CAN BE INJURED WHILE RIDING ON AND OBSERVING MINIATURE TRAINS.**

I, the undersigned, as a member or legal guardian of a member of the New Jersey Live Steamers, Inc. (hereinafter referred to as "NJLS, Inc."), recognize and understand that NJLS, Inc and its members, volunteers, and associates are engaged in the non-professional pursuit of the hobby of model railroading and that their property and equipment has been built and maintained by amateurs. As such, said property and equipment has not been certified as safe by any organization, individual, or agency, nor is it represented to be safe by NJLS, Inc. I am aware that such activities involve the use of heavy machinery, boilers, and other potentially dangerous materials and conditions, and such activities, including riding on and observing the trains, may be dangerous to my health and property. Further, I understand that NJLS, Inc. makes no claim to any particular mechanical expertise in the construction, maintenance, and operation of a live steam railroad, or other forms of locomotive power.

**I WILLINGLY AND FREELY accept and understand that riding on, operating, and observing miniature trains can be a DANGEROUS and HAZARDOUS activity with inherent risks. I HEREBY ACKNOWLEDGE, ACCEPT AND FREELY AND EXPRESSLY ASSUME ALL RISKS OF INJURY TO ANY OR ALL PARTS OF MY BODY, INCLUDING DEATH, THAT EXIST IN RIDING ON, OPERATING, AND OBSERVING MINIATURE TRAINS WHILE USING THE PROPERTY OF NJLS, Inc.** Nonetheless, I agree to voluntarily participate in the activity of riding on, operating, and observing miniature trains.

By signing this acknowledgement, I hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify NJLS, Inc. and all of its members, officers, directors, supervisors, and agents, individually, from any and all liability, loss, injury, costs, claims, actions, property damage, or death arising, in whole or in part, from any negligence on the part of NJLS, Inc., its members, officers, directors, supervisors, or agents, and/or any other persons with whom I may be interacting.

I understand that this Acknowledgement and Release covers any injuries and illnesses, both physical and mental, currently known or to occur in the future. I specifically understand that I am releasing, discharging, and waiving any and all claims or actions that I may have presently or in the future for the negligent acts or omissions of NJLS, Inc.
